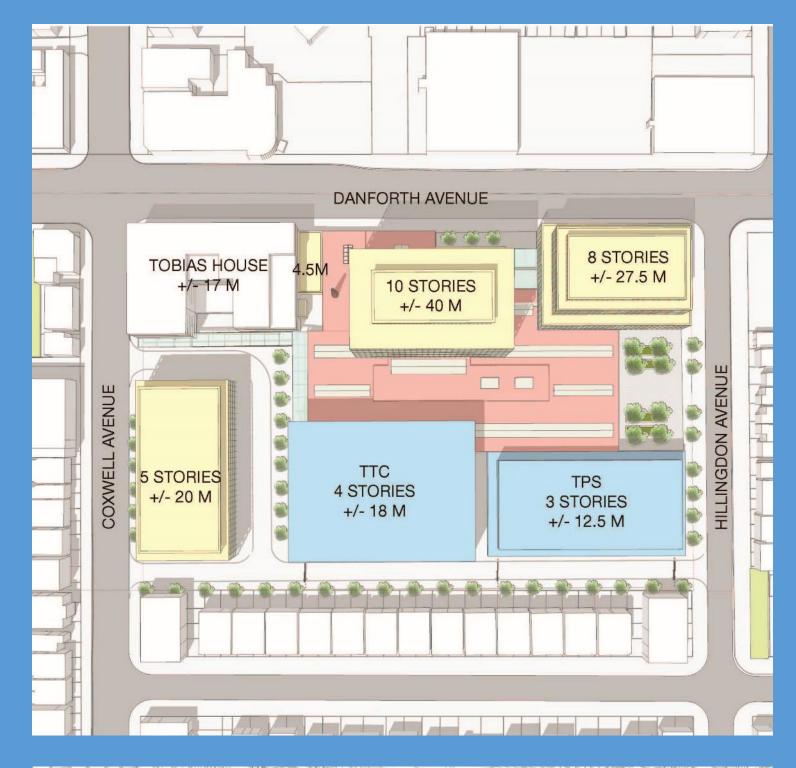
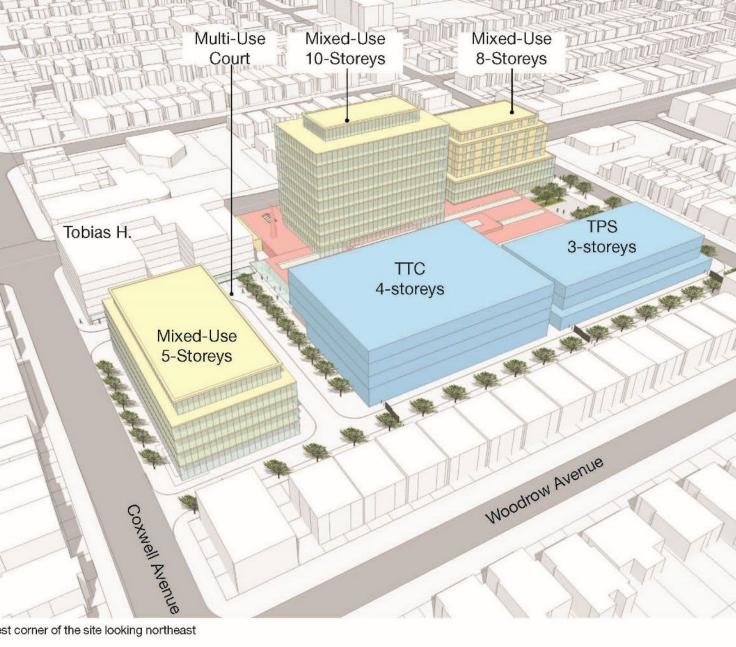

#### PROJECT PURPOSE

- to Design & Build a new 55 Division
   Police Station at 1627 Danforth Ave.
- will replace existing 55 Division
   Station & Sub-Station (101 Coxwell Ave. and 41 Cranfield Rd.);
- Transformational Task Force recommendation;
- will reduce long-term costs of operating 2 buildings - modernized, economical & more efficient public safety delivery model;
- TPS Board approval (Jan. 2018);
- City Council approval of site (2019);



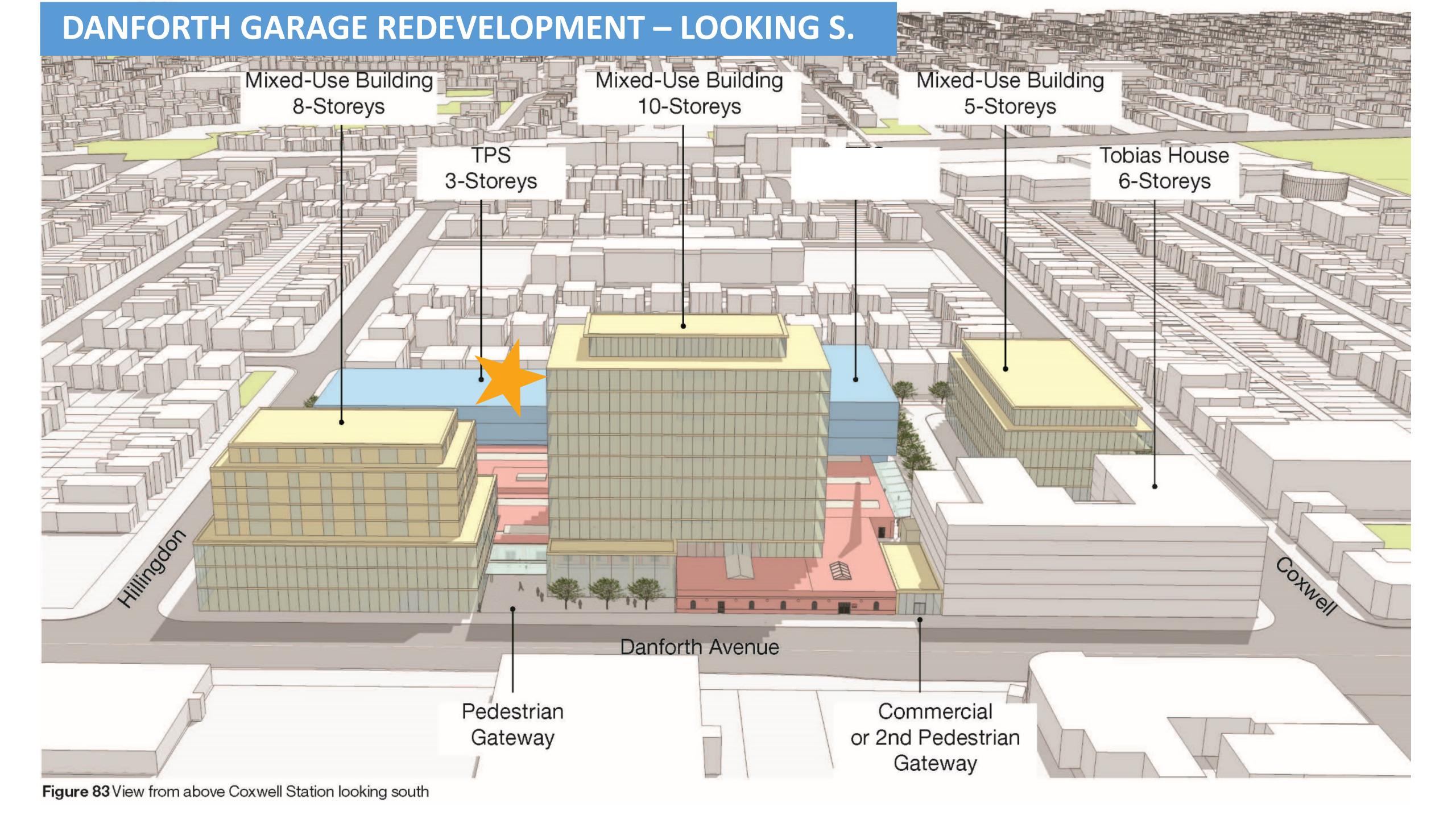
#### **ABOUT THE PROJECT**

- 1st Phase (Block "D") of the larger Danforth Garage redevelopment;
- once designed, construction is expected to take ± 3 years (occupancy expected in Q1 2027);
- ± 70,000 sq. ft. GFA (above grade);
- ± 250 parking garage spaces (TBC);
- \$50.5 M Project Budget approved;



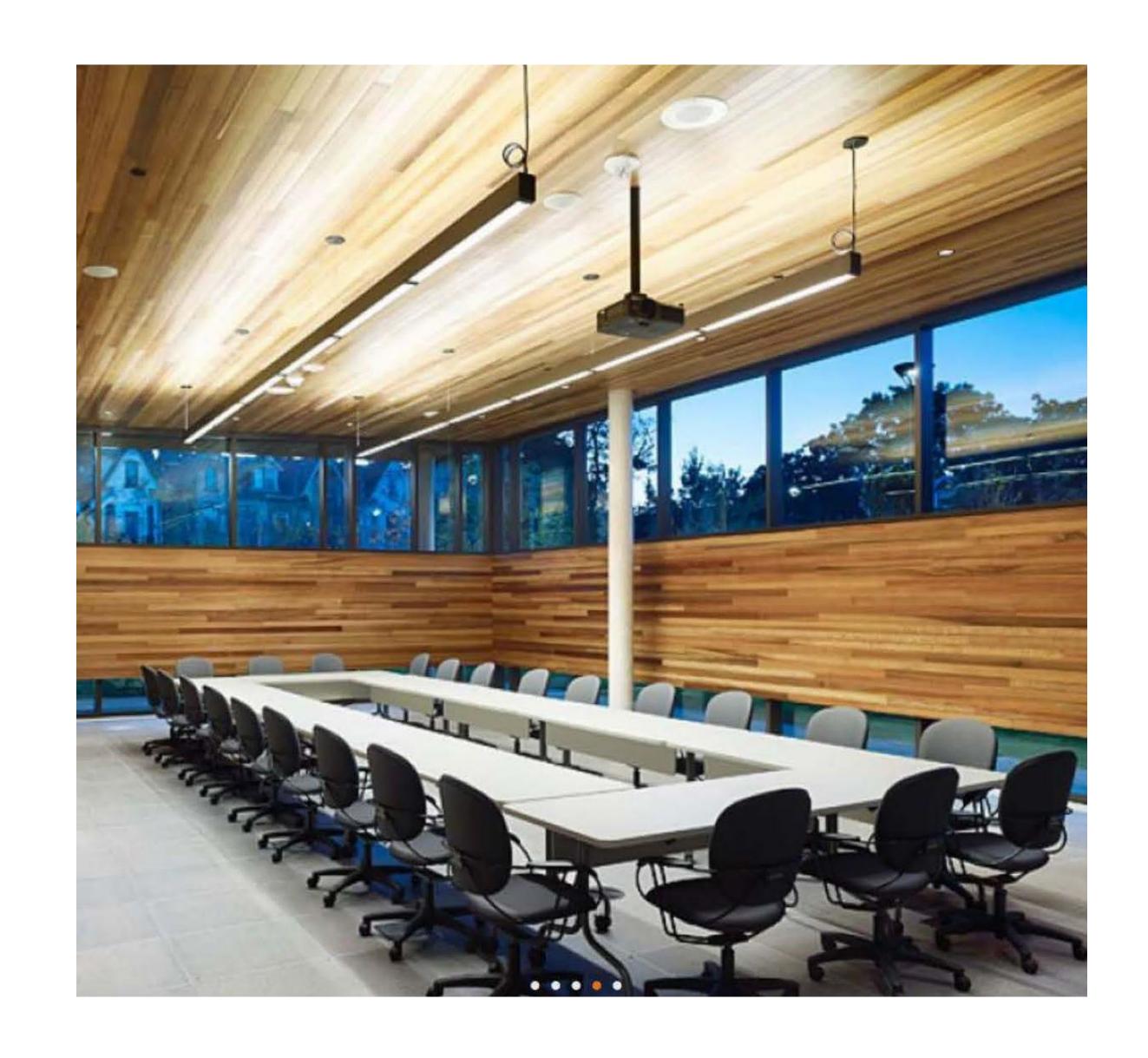

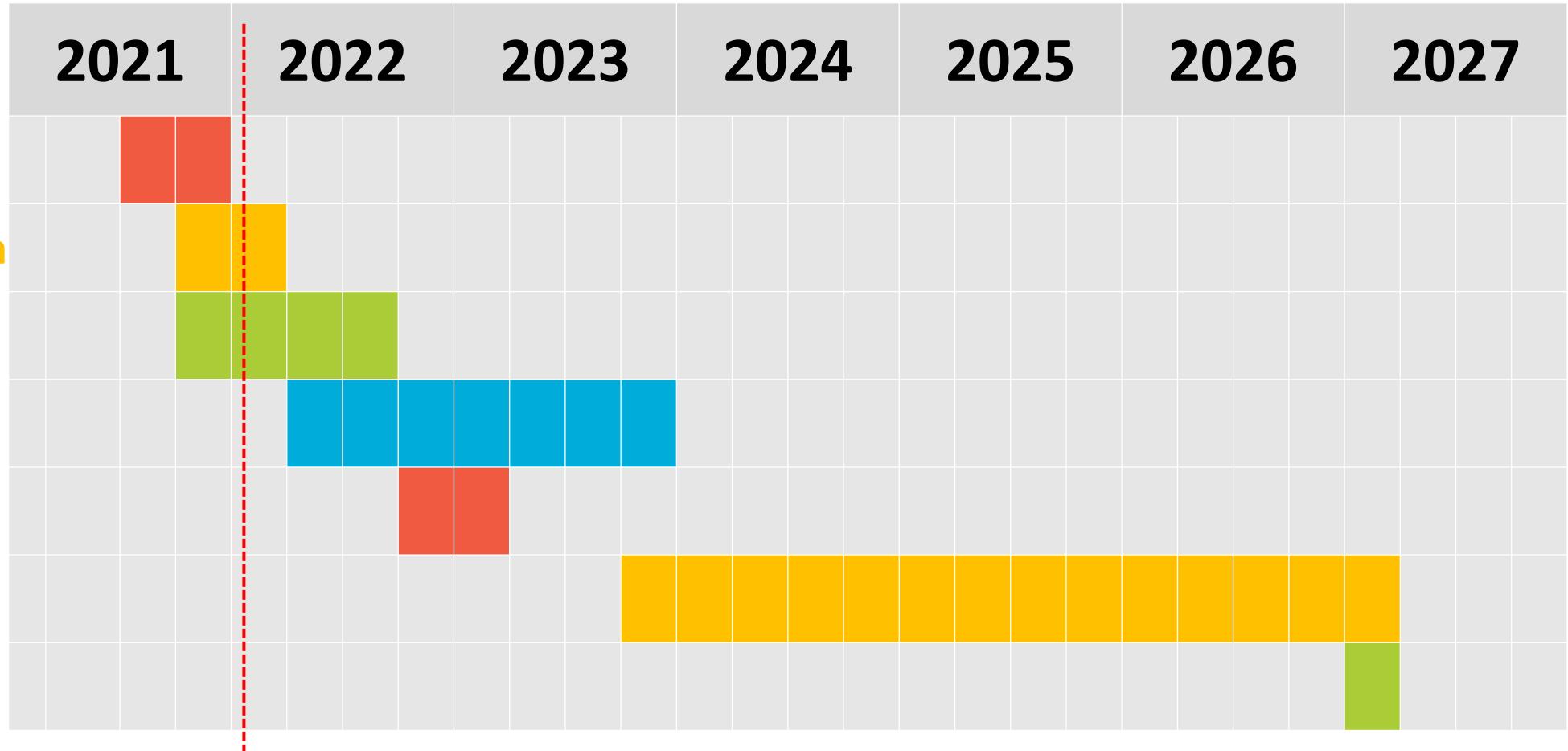

The new station will replace the existing 55 Division Station & Sub-Station (101 Coxwell Ave. and 41 Cranfield Rd.), and is a Transformational Task Force recommendation which will reduce long-term costs of operating 2 buildings, resulting in a modernized, more economical & more efficient public safety delivery model.

#### **Project Timeline**

- . December 2019: WZMH Architects hired through a Request for Proposal (RFP) process
- · Summer 2021: Design Kick-off
- Summer 2021 to Spring 2022: Community Consultation, leading to Concept Design
- Summer 2022 to Fall 2022: Schematic Design
- . Winter 2022 to Winter 2023: Preparation of construction/contract drawings & Approvals
- · Summer 2023: Procurement of construction services
- Winter 2023 to Winter 2026: Anticipated construction

#### **ACTION ITEMS FROM LAST MEETING**

1. tour of 14 Division station (possibly 11 Division station) - an example of a new police station designed to fit within a residential neighbourhood.

(Alternatively, CRG members may wish to visit these building on their own, as access is restricted to the exterior and lobby/Community Room only).

2. Superintendent Stroble will be asked to meet with Tobias House residents to describe the **release process** (or discuss this at the next meeting (CRG meeting 02)) to allay concerns about the release of individuals from the new police station.

# CRG Meeting 01: Guiding Principles & Vision

#### DANFORTH GARAGE - GUIDING PRINCIPLES

- 1.Leverage the City-owned lands to promote city building and encourage partnership with local residents, businesses, and community providers in order to generate animation and employment opportunities on site.
- 2.Create an integrated civic hub that will be home to a diverse mix of uses that will establish, activate, and animate an inclusive development for the community.
- 3. Adaptively reuse the existing historical TTC barns in a manner that speaks to the local history of public transit and evolution of transit in the City.
- 4.Development to be guided by a comprehensive planning and design process that aligns with other City initiatives, studies and policies (including the design guidelines for the Danforth Avenue Planning Study and the Toronto Green Standard) with community consultation throughout.

- 5. Appropriately integrate design with the existing neighbourhood context.
- 6.Future development of the site will promote the culture of universal accessibility and ensure universal access to all of the site, its buildings and spaces.
- 7. Create a vision and built form that exemplifies design excellence in architecture, landscape architecture and urban design.
- 8. Weave open space through the built form to create opportunities for welcoming public gathering spaces and pedestrian access where feasible.
- 9.Develop strong connections with the surrounding area that will improve and encourage public transit and active transportation access and use.
- 10. Future development of the site will build connections to the city's indigenous heritage and the local arts community.

#### 55 DIVISION - GUIDING PRINCIPLES

#### The 55 Division Police Station Development:

- 1. Will be part of an integrated civic hub that will be home to a diverse mix of uses. The police station will be **thoughtfully integrated within the larger redevelopment**, striking a **balance** to:
  - help to establish, activate, and animate an inclusive development for the community, yet
  - be mindful that not every community member feels welcome at a police station or with police overlook of public and semi-public areas, and that as a workplace the police station will be provided with security, confidentiality and privacy.
- 2. Will be an <u>inclusive</u> building for all members of the community.
- 3. Will promote the culture of <u>universal</u> <u>accessibility</u> and ensure universal access to the site, the building and its spaces.

- 4. Will be guided by a comprehensive planning and design process that <u>aligns with other City</u> <u>initiatives, studies and policies</u> (including the design guidelines for the Danforth Avenue Planning Study and the Toronto Green Standard) with <u>community consultation throughout</u> via Community Resource Group meetings, Town Hall meetings, a website and social media.
- 5. Will be thoughtfully integrated with the existing neighbourhood context.
- 6. Will create a vision and a built form that exemplifies design excellence in architecture, landscape architecture and urban design.
- 7. Will develop <u>strong connections with the</u> <u>surrounding area</u> that will improve and encourage public transit and active transportation access and use.

- be thoughtfully integrated with the existing neighbourhood and the larger Danforth Garage redevelopment, striking a balance between:
  - activating and animating the larger Danforth Garage redevelopment, vs.
  - overlook concerns of some in the community, and a workplace need for privacy, confidentiality and security;
- aspire to design excellence, and will prioritize environmentally sustainable design; and
- be designed for access through all modes of transportation (e.g. walking, biking, transit, and driving).
