



07-02 Fail to Remain Collisions

Status: Amended

Issued: 2025.07.02

Replaces: 2024.09.04

Rationale

The *Highway Traffic Act (HTA)* defines circumstances where fail to remain collisions are reportable and has developed provincial forms to be submitted. This procedure establishes the criteria, responsibility and process for investigating collisions in accordance with the *HTA*, *Ontario Regulation 392/23 Adequate and Effective Policing (General) made under the Community Safety and Policing Act* and the best practices for the Toronto Police Service.

Procedure

Traffic Services personnel are responsible for investigating fail to remain collisions in cases where

- there are fatalities
- injuries are life threatening
- the occurrence remains unsolved after 48 hours of being reported
- the collision occurs on an expressway

Priority Response Unit (PRU) Divisional Traffic Support may assist with fail to remain collisions in cases where

- injuries are not life threatening
- collision does not occur on an expressway

If an officer is not required to conduct an “at scene” investigation as determined by the criteria contained in Procedure 07–01, any person reporting a fail to remain collision shall be directed to the most convenient Collision Reporting Center (CRC).

A TPS 334 must be submitted for all unsolved fail to remain investigations and submitted to Traffic Services – Investigative Services within 48 hours of the initial report. The only exception is when the fail to remain investigation is solved within 48 hours with all involved vehicles and drivers identified.

Police Officer

1. When investigating a fail to remain collision shall
 - comply with Procedure 07–01
 - collect evidence in compliance with Procedure 04–21
 - notify the Communications Operator – Communications Services of the description, number plate, direction of travel, damage to suspect vehicle and description of the driver, if available
 - in cases involving life threatening injuries or fatalities
 - protect the scene

- comply with Procedure 07–03
 - interview any witnesses
 - complete
 - a TPS 334 except in those instances where the collision was reported at a CRC
 - the applicable eReports forthwith, selecting Yes for the BOLO option
- ➔ *Records Management Services – Operations (RMS – Ops) will create and post a BOLO.*

Officer in Charge

2. Upon receipt of any relevant reports shall ensure any report for a fail to remain collision, where the investigation has not been completed within 48 hours of the occurrence being reported, is forwarded to Traffic Services.

Officer in Charge – Traffic Services

3. Upon receipt of any relevant reports shall ensure the pertinent information is recorded on the Central Accident Registry System (CARS).

Definitions

For the purposes of this Procedure, the following definitions will apply:

Reportable Collision means every person operating a motor vehicle or streetcar involved directly or indirectly in a collision that results in personal injury, death, or property damage exceeding \$5000, is required to report and furnish information forthwith to the nearest police officer in accordance with the *Highway Traffic Act*.
